





### **Survey Methodology**

On behalf of Abriendo Puertas/Opening Doors and UnidosUS, BSP Research collected opinions from 1,300 Latino parents and primary caregivers of children 5 years of age or younger including expectant families using a blended data collection approach that included online surveys, and live telephone interviews conducted via landlines and cell phones. The survey was available in English or Spanish and carries an overall +/- 2.7% margin of error, with larger margins for sub-samples. Upon completion, the data were weighted to match the U.S. Census ACS for parents and grandparents of Latino origin. The survey was conducted from September 6-October 4, 2022 and includes oversamples for both New Mexico and Los Angeles County.
