
## **Tracking the Global Recession: Economic Indicators - Germany**

NOTE: The charts plot four main economic indicators similar to those tracked by the <u>NBER</u> dating committee for the U.S.; each series is indexed to 100 at the business cycle peak. The red line indicates the <u>current recession</u>. The solid blue line indicates the average of the <u>previous eight recessions</u>, starting with the April 1973 peak. The two dashed lines report the highest and lowest values recorded across these previous recessions.
