



## Tracking the Global Recession: Economic Indicators - United Kingdom

NOTE: The charts plot four main economic indicators similar to those tracked by the <a href="NBER">NBER</a> dating committee for the U.S.; each series is indexed to 100 at the business cycle peak. The red line indicates the <a href="current recession">current recession</a>. The solid blue line indicates the average of the <a href="previous seven recessions">previous seven recessions</a>, starting with the June 1973 peak. The two dashed lines report the highest and lowest values recorded across these previous recessions.
